Message from Zonta Club of Amherst President:

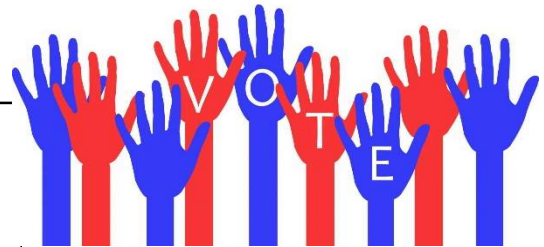
Hello Zonta members!
